1. Construction Update

Mark Oliver and Karen Hoblit walked around Building 5 about a week ago to determine the things we need to get contractors to include in their bid in detail. In the process of vetting contractors and getting bids to replace the 4X4 posts to 6X6 posts. One bid from A-Plus was \$71,000, including \$20,000 for one stairwell. Board members agree that is too expensive for posts. Plan is to wait on the stairs and right now get a reasonable bid on the posts. Trying to get 2 additional bids. This bid did not include handrails and spindles because that would add \$500/rail/balcony labor and material, with painting to still be required.

4. Stairwells

Stairwells will be done last. Mark will get some good info on what to do with steps. Looking for someone (contractor) who can say this is what we can do and this is what it will cost. Getting 2-3 ideas of best solution. The problem with metal steps is that they continue to rust, requiring painting 2-3 times a year. Karen said we will make decision on stairwells in Spring, giving Mark more time to get answers and report at the next HOA

Meeting in the Spring. Karen suggested to start scheduling regular paintings maintenance and planning for long-term. It was decided to hire Mustard Seed (Dan) so that he can have Andy do the painting, dry wall in electrical rooms (during Winter). More economical to hire him to do these maintenance jobs than to hire someone else since Andy is already up here.

5. Fire Alarm System
